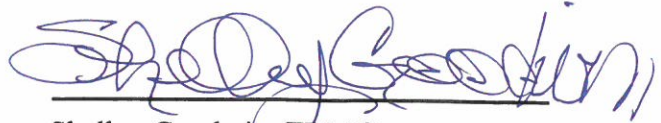
Verbal Comments:

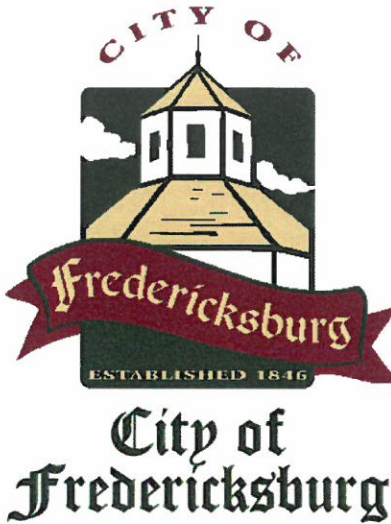
